CUCURBITS: Includes all members of Crop Group 9 such as, but not limited to: Balsam apple, Balsam pear, Bitter melon, Chayote, Chinese cucumber, Chinese waxgourd (Chinese preserving melon), Citron melon, Cucumber, Gherkin, Edible gourd (includes: hyotan, cucuzza, henchmia and Chinese okra), Muskmelon (includes: cantaloupe, true cantaloupe, casaba, crenshaw melon, golden pershaw melon, honeydew melon, honey balls, mango melon, Persian melon, pineapple melon, Santa Claus melon, and snake melon), Pumpkin, Summer squash (includes: crookneck squash, scallop squash, straightneck squash, vegetable marrow, and zucchini) Watermelon, Winter squash (includes: butternut squash, calabaza, hubbard squash, acorn squash and spaghetti squash)

FRUITING VEGETABLES: Includes all members of Crop Group 8 such as, but not limited to: Eggplant, Groundcherry, Pepino, Pepper (includes: bell pepper, chili pepper, cooking pepper, pimento, sweet pepper), Tomatillo, and Tomato

For reduction of damage caused by garden symphylan, apply specified dosage to the top of the beds prior to transplanting.

Spray should cover the entire top of the beds. Thoroughly incorporate to a depth of approximately 4 to 6 inches.
