GENERAL INFORMATION

BENVIREO™ CALCIUM is manufactured and designed for foliar applications on plants to prevent or correct calcium deficiencies that usually occur when plants are small and may limit crop growth and yields. **BENVIREO CALCIUM** is readily available to the plant because of the natural complexing properties. It is designed for foliar row or broadcast applications and is water soluble and non-toxic to plants when applied as directed.

BENVIREO CALCIUM is a yield-enhancing formulation that contains calcium chloride complexed with soy protein hydrolysate. **BENVIREO CALCIUM** is a proprietary formulation that provides a wide range of mixing ease with other fertilizers or chemicals.

DIRECTIONS FOR USE

SHAKE WELL BEFORE USING. KEEP FROM FREEZING.

Dilute one part **BENVIREO CALCIUM** with 20 or more parts water. Apply using a spray method and in an adequate amount of water that will provide complete coverage of the plants. Use of a nonionic wetting agent may improve spray coverage of certain hard-to-wet plants. **Do Not Apply Undiluted.**

BENVIREO CALCIUM can be included in a regular spray program on crops. Consult with a Wilbur-Ellis representative on compatibility with other spray materials. The rate of application will depend on the crop, stage of growth, and severity of deficiency. The maximum recommended rates are for mature, full-sized plants. Reduce the rates proportionately when spraying smaller plants.

BENVIREO CALCIUM may be used on legumes, grain crops, root crops, cucurbits, cole crops, leafy vegetables, woody and herbaceous ornamentals, deciduous fruit, vine crops, tropical and subtropical fruit, many other crops, and turf.

TURF: Apply 1-2 fluid ounces per 1,000 sq. ft. during periods of active growth. **FIELD CROPS AND VEGETABLES:** Apply 2-64 fluid ounces per acre during periods of rapid growth or nutritional stress. The applications may be repeated 2 or more times throughout the growing season. GRAPES AND BERRIES: Make an application of 2-64 fluid ounces per acre after active growth begins. The applications may be repeated at intervals of 1 week or more through the vegetative growth period.

TREE CROPS: Make an application of 1 gallon per acre after the beginning of active growth. The application may be repeated weekly throughout the growing season. Mid and late season sprays directed to cover the fruit may help to reduce the effects of calcium-related disorders. For post-harvest fruit treatment, dilute at a rate of 0.5-1.0 gallon per 100 gallons of water. **Pears:** Apply 8-192 fluid ounces per acre after the beginning of active growth. The application may be repeated at 2 to 4-week intervals throughout the growing season.

ORNAMENTAL TREES, SHRUBS, AND FLOWERING PLANTS: Dilute at a rate of 2-32 fluid ounces in 10 or more gallons of water and spray to complete coverage.
