BENVIREO® MULTUS™ is manufactured and designed for foliar applications on plants to prevent or correct trace element deficiencies that usually occur when plants are small and may limit crop growth and yields. **BENVIREO MULTUS** is readily available and rapidly absorbed by the plant because of the natural complexing properties. It is water soluble and non-toxic to plants when applied as directed.

BENVIREO MULTUS is a yield-enhancing formulation that contains complexed micronutrients. **BENVIREO MULTUS** is a proprietary formulation that provides a wide range of mixing ease with other fertilizers or chemicals.

DIRECTIONS FOR USE

SHAKE WELL BEFORE USING. KEEP FROM FREEZING.

Dilute one part **BENVIREO MULTUS** with 20 or more parts water. Apply using a spray method and in an adequate amount of water that will provide complete coverage of the plants. Use of a nonionic wetting agent, such as SYL-COAT®, may improve spray coverage. **Do Not Apply Undiluted.**

BENVIREO MULTUS can be included in a regular spray program on crops. Consult with a Wilbur-Ellis representative on compatibility with other spray materials. The rate of application will depend on the crop, stage of growth, and severity of deficiency. The maximum recommended rates are for mature, full-sized plants. Reduce the rates proportionately when spraying smaller plants.

BENVIREO MULTUS may be used on legumes, grain crops, root crops, cucurbits, cole crops, leafy vegetables, woody and herbaceous ornamentals, deciduous fruit, vine crops, tropical and subtropical fruit, many other crops, and turf.

ALFALFA: Apply 2-32 fluid ounces per acre during periods of first growth and after first cutting at 4th to 6th leaf stage. The applications may be repeated 2 or more times throughout the growing season.

BEANS: Apply 2-32 fluid ounces per acre at first cultivation and 12-14 days before blossoming.

CORN: Apply 1 quart to 1 gallon during periods of rapid growth. Applications may be repeated 2 or more times through the season.

FRUIT TREES: Apply 2-32 fluid ounces per acre before blossoming and shortly after petal fall.

SOYBEANS: Apply 1 quart to 1 gallon during periods of rapid growth. Applications may be repeated 2 or more times through the season.

TREE NUTS: Apply 2-32 fluid ounces per acre shortly after petal fall.

POTATOES: Apply 2-32 fluid ounces per acre at row closure. Applications should be applied during periods of rapid growth or nutritional stress. Applications may be repeated 2 or more times throughout the growing season.

RICE: Apply 2-32 fluid ounces per acre just before booting.

WHEAT: Apply 2-16 fluid ounces per acre when plants are 6 inches high and 12-14 days before booting.

DO NOT APPLY TO PEAR FRUITS – THIS PRODUCT WILL MARK FRUIT.

Always jar test new combinations for compatibility prior to field mixing. Avoid mixing with fertilizers containing phosphite.
