### DIRECTIONS FOR USE

**FOLIAR:** Apply 1-2 pints with sufficient water for thorough coverage by ground or air application.

**SOIL:** Apply 1-2 pints or more per acre with fertilizer or with water. Repeated applications may be beneficial. This product may require agitation when mixed with fertilizer for prolonged periods.
