**PURIC**<sup>®</sup> **WSG** dry granules are extracted, refined, water-soluble humic acids and may be applied to most crops. This product can be blended with most dry fertilizers, including urea blends, to aid with nutrient uptake and exchange.

This product is a water-soluble granule and can be dissolved in water.

#### **DIRECTIONS FOR USE**

**SOIL:** Broadcast, band, or prepare seed or transplant bed with 1-20 pounds per acre with dry fertilizer program. If applying with seed or in-season, incorporate with water or tillage. Multiple applications can be beneficial.

**SEEDING:** Band or broadcast 1-5 pounds with seed on cereal crops at planting.

**PURIC WSG** is formulated to be mixed with most dry blends. Do not mix with fertilizers containing calcium or solution with low pH. Proper mixing procedure:

1. Add all dry NPK and micros to blender

2. Add desired rate of **PURIC WSG** 

3. Blend until homogenous

In areas of high humidity or when adding AMS/urea blends, use of a drying agent is recommended.
