GENERAL INFORMATION

SINGE™ is a uniquely formulated spray adjuvant developed to enhance the performance of certain post-emergence herbicides. **SINGE™** improves leaf coverage and absorption, reducing the negative effects of adverse environmental conditions.

DIRECTIONS FOR USE | SHAKE WELL BEFORE USE

PER ACRE: 1 - 2 pints (16 - 32 fl oz). Use the higher rate on hard to control weeds or weeds under stress.

BY VOLUME: 1.0% v/v

(1 gallon of SINGE™ per 100 gallons of spray solution).

Aerial Application: When applying aerially, follow chemical label directions including a minimum water volume per acre. Carefully read and follow directions on the label of the chemical with which **SINGE™** is to be used. Include fertilizer (UAN) or ammonium sulfate at rates specified on the chemical label. Do not substitute **SINGE™** for water required by the chemical label. For local recommendations, consult an agricultural authority or mix in this order:

1. Dry flowable chemicals
2. Wettable powder chemicals
3. Flowable chemicals
4. Water-soluble chemicals
5. Emulsifiable concentrate chemicals
6. Add **SINGE™** and continue agitation

PRECAUTIONARY STATEMENTS

Avoid contact with eyes and skin. Avoid breathing vapors or spray mist. Wear eye/face protection and protective gloves. Do not eat, drink, or smoke when using this product.
